General Description

The flocked swabs feature perpendicular nylon(to use flocking swab) and PET(to use throat swab) fibers that optimize specimen collection. The swabs also feature a molded breakpoint that allows you to safely and easily break off the swabstick, and several breakpoint options are available.

Intended Purpose

A nasopharyngeal or oropharyngeal swab is a method for collecting a clinical test sample of nasal or throat secretions from the back of the nose and throat. The sample is then analyzed for the presence of organisms or other clinical markers for disease.

Performance Characteristics

PMW Flocked Swab is a specimen collection swab that has a tip flocked with soft nylon fiber. The nylon flocked specimen collection swabs have a solid plastic shaft with a molded breakpoint site.

To collect the sample, the swab is inserted in the nostril and gently moved forward into the nasopharynx, a region of the pharynx that pharynx that covers the roof of the mouth. The swab is then rotated for a specified period time to collect secretions, then the swab is removed.



- ① Peel off the sealed film package then, pull the product out after grab the body handle.
- ② Collecting specimen from the mouth, nasal cavity, ear or anus. In order to reduce the possibility of other contamination, the TIP part of the head is in contact with the suspected infection area quickly.
- 3 Rotate the body handle a few times to ensure that the specimen are effectively collected to the head end.
